### TOUR INFORMATION

- Tour price for the program ending in Madrid on November 20th is **EURO 2080** (approximately USD 2325) per person. All hotel accommodations, coach class train tickets, sightseeing, admissions and services of local guides, are included.
- Hotel Accommodations: The tour price includes all hotel accommodations in hotel rooms with private baths. Although the level of the accommodations may differ slightly from hotel to hotel, we are committed to your comfort. Two-bed rooms are reserved in most hotels. King-size beds are not available in most hotels; what is considered king-size usually consists of two single beds pushed together and made up separately, but with one headboard. Some two-bed rooms may have two twin - not full- or queen-size - beds.
- Entrance fees are included as specified in the itinerary.
- Baggage: We suggest one piece of luggage per person and one carry-on bag. The Travel Agent and/or Tour Operator, shall not be held responsible for any damage to or loss of luggage/personal items. All damage/loss must be reported at time of incident and documented in writing by local authorities for submission to the insurance company. With regard to airline baggage allowance, different carriers have different regulations for business and coach, please check with your individual carrier with regard to permitted number of pieces, weights and dimensions. The tour operator is not responsible for fees levied by any air carrier for the transport of personal belongings of any kind.

#### Not Included

- Airfare from and back to US.
- Personal Expenses: All personal expenses such as: meals not included in the proposal, laundry, valet service, tips to local guides, cabs, telephone calls, postage...

## **PAYMENT & CANCELLATION POLICY:**

- A minimum number of 18 paying participants is required to operate the tour at the above prices. However, if the final number of participants is over 24 people, given prices would be revisited to see if any further enhancement can be provided.
- A 10% deposit (non-refundable) must be received at the time of booking in order to confirm the reservation (EUR 200/person, which is approximately USD 225).
- 90 days before the beginning of the trip (i.e. by August 7rd, 2019) a down payment of 45% of the total cost shall be paid (EUR 940, approximately USD 1050)
- The remaining 45% of the total amount (EUR 940, approximately USD 1050) should be paid 30 days before the trip begins (i.e. by October 7th, 2017).
- 25% penalty applies if cancelled 90 days or less before departure;
- 50% penalty applies if cancelled 60 days or less before departure;
- 100% penalty applies if cancelled less than 15 days before the trip is scheduled to start.
- Your credit card and passport information will be required when registering at the different hotels, in case of hotel incidentals or damage.
- Extending Your Stay – Accommodations can often be made for those wishing to arrive earlier or depart later than the program dates; please ask at the time of your booking
- Responsibility - Initial registration indicates agreement with all terms and conditions as stated in this document. Mr. Moises Hassán-Amselem reserves the right to make any itinerary changes whenever, in its sole judgement, as conditions warrant.
